

FY 2016 Montana Medicaid - Fee Schedule
Home and Community Based Services for Adults with Severe Disabling Mental Illness (SDMI)
July 1, 2015

Description – Procedure code short description. You must refer to the appropriate official CPT-4 or HCPCS coding manual for complete definitions in order to assure correct coding.

Modifier - All Home and Community Based Services procedure codes must be followed by a UA modifier.

Other modifiers to follow after UA modifier:

TE = nurse supervision/oversight

TS = follow-up service

Effective – This is the first date of service for which the listed fee is applicable.

Method – Source of fee determination

Fee Schedule: Medicaid fee for listed codes.

Rates listed are maximum paid.

PA – Prior Authorization

Y: Prior authorization is required

Space: Prior authorization is not required

Homemaker, Respite and Personal Assistance rates are based on negotiations with the Department. Providers must submit semi-annual reports to the Department, Senior and Long Term Care Division, to remain eligible for this funding. Providers agree to bill at the rate outlined in their billing certification letter from Senior and Long Term Care Division. Providers understand that periodic audits will take place and a recovery will occur if they bill above their rate.
