Modifier - All Home and Community Based Services procedure codes must be followed by a UA modifier.

Other modifiers to follow after UA modifier:

TE = nurse supervision/oversight

T9 = self-direct

*Note** Prior Authorization is required on all services listed within the HCBS SDMI fee schedule excluding H0032 Case Management.
