I. Practitioner Services – Psychiatric Procedures

Mental health practitioners include physicians, physician assistants, nurse practitioners, psychologists, social workers, and professional counselors. Practitioners’ bill using standard CPT procedure codes and are reimbursed according to the Department’s RBRVS system. II. Practitioner Services – Evaluation & Management

Evaluation and Management Services may be provided by physicians, physician assistants, and nurse practitioners. Services are billed using standard CPT procedure codes and are reimbursed according to the Department’s RBRVS system.

III. Care Coordination, Community-based Psychiatric Rehabilitation, and Crisis Management Services

Crisis management services are paid on an all-inclusive bundled hourly rate to enrolled hospitals and enrolled facilities such as licensed mental health centers. Reimbursement is subject to payment authorization and limits.

#### IV. Crisis Intervention and Response

A licensed mental health practitioner who is an employee of a licensed mental health center can provide the following services in emergency situations. The licensed practitioner will submit request for reimbursement within 45 days of providing the service.

**The licensed mental health practitioner must submit documentation that supports the use of the 90839 procedure code. \***
