Montana State Level Registry

The Montana State Level Registry (SLR) will open for Program Year 2020 for Eligible Professionals (EPs) and Groups from December 1, 2020 through February 28, 2021.

What to Expect for Program Year 2020?

- EPs can continue through 2021 if they have previously attested and been paid at least once in any program year prior to and including 2016.
- All participants must attest to Meaningful Use (MU) Stage 3. No attestations will be accepted for Adopt, Implement or Upgrade (AIU).
- Beginning with program year 2019 through the end of the program, EPs must use 2015 Edition certified EHR technology. The 2015 Edition functionality must be in place by the first day of the EHR reporting period and the product must be certified to the 2015 Edition criteria by the last day of the EHR reporting period. The EP must be using the 2015 Edition functionality for the full EHR reporting period. In many situations the product may be deployed but pending certification. If the certification is received by the last day of the reporting period, the EP will be able to meet the Stage 3 objectives and measures.
- EHR reporting period for Medicaid EPs and EHs is a minimum of any continuous 90-day period within calendar year 2020.
- Unlike in previous years, there are no alternate exclusions or specifications available.
- Security Risk Assessment must be conducted by both EHs and EPs during Calendar Year 2020.
- **Broadband Access Exclusion:** CMS offers broadband access exclusions for three meaningful use objectives: Patient Electronic Access to Health Information, Coordination of Care through Patient Engagement, and Health Information Exchange. However, according to the Federal Communications Commission's (FCC) most current map, all counties in Montana are listed as having 50 percent or more of its housing units with 4Mbps broadband available. Therefore, **no providers are eligible to take the broadband exclusion for these objectives.**

Montana State Level Registry Required Documentation

The following documentation must be uploaded to the SLR for EP Program Year 2020:

- Copy of Contract with EHR Vendor (if contract is not current, upload a current invoice)
- Copy of Security Risk Assessment
- Full Meaningful Use Summary Report (All MU objectives/measures and all CQMs) or Supporting Documentation (screen shots or EHR report with PHI removed)
- Letter from the Public Health Agency (or statement/reason for exclusion, for example “We don’t give immunizations due to provider type. We are dentists.”)
- Signed and dated Program Year 2020 Attestation

Enrollment Tips

- Review our three types of enrollments to ensure you are selecting the correct application for your needs.
- Ensure all provider/facility information is up to date before submitting the application. Delays can be caused by taxonomies not matching NPPES, name on application doesn't match the name on the license, the wrong NPI is listed on the application, etc.
- Ensure that all supplemental documents are submitted with the application reference number within 90 days of submitting the online application. These documents can be faxed or mailed in. An email will be sent to the email address on the application once the documents have been added to the file. Please note, applications cannot be processed until all supplemental documents are received.
- Don't send unnecessary documents. For example, submitting an EFT form or W-9 form for a Rendering Only and Abbreviated provider application. Another example is including group documentation when the application is for an individual.
- Do not remove the email address used to create the application. You can add additional emails. Please make sure your email address is a business/professional email address. The original email address is where all communication from the Enrollment Team will go.
- If you list the board certification and CLIA license on the application, please send in the hard copy in the supplemental documents.

Provider Relations understands that keeping track of pages on multiple websites can be cumbersome. To make things easier for providers that need has been eliminated!

On each page of the Provider Website that requires documents for claim submission from the DPHHS Website, the DPHHS links are now provided on the individual provider type pages. For example, the Mental Health Centers provider type page has a link near the bottom of the page to both Adult and Children's Mental Health Provider information on the DPHHS Website. Many of the program officers have also linked provider information from the appropriate DPHHS pages to the corresponding Provider Website pages as well.
