

# **Proposed Medicaid Mental Health Services**

## **Individuals 18 years of age and older Fee Schedule**

### **Effective July 1,~~2020~~2021**

#### **Acute Inpatient Services**

Acute care hospital services will be reimbursed for Medicaid members under the Montana Medicaid program's Diagnosis Related Group (DRG) reimbursement system. All out-of-state admissions of Medicaid members require prior authorization.

#### **Evaluation and Management Services**

Evaluation and management (E/M) services may be provided by physicians and other qualified health care professionals. Providers bill using standard CPT E/M procedure codes and are reimbursed according to the Department's RBRVS system. Partial hospitalization services are available to Medicaid members according to the following schedule:

## Dialectical Behavior Therapy (DBT) Services

A licensed mental health professional must be trained and certified in Dialectical Behavior Therapy to provide these outpatient services. Dialectical Behavior Therapy Skill Development may be reimbursed to mental health center and/or mental health provider types.
