This program is only available for those persons in detention centers, pre-release programs, and bridge funding for those persons discharged from Montana State Hospital.

## **Evaluation and Management Services**

Evaluation and management (E/M) services may be provided by physicians and other qualified health care professionals. Providers bill using standard CPT E/M procedure codes and are reimbursed according to the Department's RBRVS system. Please refer to https://medicaidprovider.mt.gov.

## **Mental Health Professional Services**

Individual psychotherapy, group therapy, family therapy, and crisis services may be provided by licensed clinical psychologists, licensed clinical social workers, licensed clinical professional counselors, and licensed clinical candidates under the supervision of a mental health center.
