## **COVID-19 Vaccine Administration Billing Guidance**

The American Medical Association (AMA) established four Current Procedural Terminology (CPT) codes related to administering COVID-19 vaccines. These codes are required when submitting claims to Montana Healthcare Programs for reimbursement.

## Physicians, Mid-Levels, and Hospitals

Physicians, mid-levels, and outpatient prospective payment system hospitals will be reimbursed the lower of submitted charges or the rates listed above. Critical Access Hospitals will be reimbursed utilizing their facility specific outpatient cost to charge ratio.

#### **Nursing Facilities**

Administration of a COVID-19 vaccine is considered an ancillary service for nursing facilities and eligible for reimbursement outside of the nursing home per diem. Nursing facilities would bill for this ancillary service on a CMS-1500 utilizing the appropriate administration CPT code.

#### **Indian Health Services / Tribal 638**

Administration of a COVID-19 vaccine will be reimbursed at the applicable fee schedule rate. When the vaccine administration is provided during an all-inclusive rate (AIR) eligible encounter, the vaccine administration will be paid for in addition to the AIR. Vaccine administration is billed with revenue code 771 and the applicable COVID-19 vaccine administration CPT code. If the administration is provided during an office visit, the appropriate revenue codes may be billed for each service.

The department is currently implementing system modifications to pay COVID-19 vaccine administration fee at the fee schedule rate. Once the system updates have been made, the department will mass adjust claims.

#### Federally Qualified Health Centers (FQHC), Rural Health Clinics (RHC)

Administration of a COVID-19 is considered an incident to an encounter, like the flu vaccination, and is therefore not separately reimbursable. The incident to status is subject to change based on CMS guidance.
