# Effective June 1, 2021

## Process to Enter PASRR requests through the Qualitrac portal

Mountain-Pacific Quality Health, in partnership with Telligen, is providing the utilization management and review services for the Pre-Admission Screening and Annual Resident Review (PASRR) program and will be transitioning to portal submission for all Level I PASRR requests.

Telligen's industry-leading technology platform, called Qualitrac, offers a secure, HIPAA-compliant portal that allows providers to submit Level I PASRR requests and receive determinations. Benefits of the portal include:

- 24/7 provider access to:
  - Submit new requests electronically drag and drop as opposed to faxing documents
  - Electronically upload supporting documentation, e.g., History & Physical, medication list, etc.
  - Review status of pending requests in real-time
  - Review determinations (notification that reviews are completed is emailed to requester)
  - Retrieve history of previous requests and determinations.
- Two-way, secure data exchange between Mountain-Pacific and the requesting provider
- · Efficiencies, time saved and reduced number of telephone calls

Implementation:

- Implementation for PASRR submissions via Qualitrac is on track for June 1, 2021.

#### **AUTHORIZED OFFICIAL TRAINING:**

- Wednesday May 12, 2021 at 10am or Tuesday May 18, 2021 at 2pm (same training only need to sign up for one)
- Authorized Officials are the individuals for your organization who will manage provider accounts within your organization. They are appointed by a Provider Executive, e.g., the duly authorized representative permitted to bind your organization and agree to the terms and conditions of the Provider Portal Agreement (e.g., CEO, CIO, etc.).
- All organizations will need at least one (1) Authorized Official

#### **PROVIDER USER TRAINING:**

- Tuesday May 25, 2021 at 11am or Thursday May 27<sup>th</sup>, 2021 at 2pm (same training only need to sign up for one)
- Provider users are those who will be entering Level 1 PASRR requests daily. You can have as many users as your organization allows.

- Training sessions will be recorded and available to view on-demand (at the website below, under the Education & Training tab)
- Once the new process is fully implemented and **no later than August 1, 2021**, Mountain-Pacific will not accept faxed or mailed requests from providers unless a provider seeks and is granted an exemption from the Montana Department of Public Health and Human Services.
